## **President's Message**



As we close another productive year at TPS, I'm pleased to share several milestones that reflect our profession's evolution and the strength of our community.

Foremost among these achievements was the official adoption of the Professional Technologist (PTech) designation, which now replaces the long standing Applied Science Technologist title. This

transition marks an important step in aligning Saskatchewan with national standards and reinforcing the credibility and clarity of our professional framework.

In May, TPS participated in the Technology Professionals Canada (TPC), and Technology Accreditation Canada (TAC) AGM's in Winnipeg, where representatives from across the country gathered to discuss accreditation, mobility, and the future of the profession. Over the summer, TPC also undertook the development of a new strategic plan, working closely with an external consultant to chart a clear and modernized direction for the years ahead.

Complementing this work were significant revisions to TPC's Unanimous Members Agreement and Bylaws—updates that became especially important following the departure of ASET and ASTTBC from TPC. These changes ensure that TPC remains stable, representative, and well positioned to serve its remaining provincial partners.

Closer to home, TPS completed a new Strength, Weaknesses, Opportunities, and Threats (SWOT) analysis informed directly by feedback from last year's registered member and student member surveys. Your insights continue to guide our priorities, and this refreshed assessment will help shape our operational and strategic decisions moving forward. We were also pleased to see such a strong turnout at our 60th Annual Meeting in May, hosted at the historic RCMP Depot in Regina. The engagement and thoughtful discussion from members reaffirmed the value of our shared commitment to professional excellence.

Thank you for your continued support, your professionalism, and your dedication to strengthening the technology community in Saskatchewan. Together, we are building a resilient and forward looking future for our profession.


### The Technology Ring




TPS 2025 Salary Survey Results are now posted under the Member Zone Tab. Log in to your registrant profile account.

#### Tricia Pollock, PTech - Professional Career

Tricia became an Associate Member in 1994 after graduating from the Civil Engineering Technology program at SIAST Palliser Campus and gained her PTech status in the following years. After spending time with an asphalt company and a small general contractor at a uranium mine, Tricia joined the City of Saskatoon's Engineering Department. There she learned the inner workings of the municipal infrastructure of the City and later moved into the Public Works Department. In 2004, her career began to take a turn when Tricia enrolled into the University of Saskatchewan extension division and obtained her Occupational Health and Safety Certificate from the University of Alberta. She worked her last four years with the City in the Water and Wastewater Departments as a safety advisor.

In 2008, following the love of construction she had gained in the years previous, Tricia took her engineering and health, safety and environment knowledge to PCL Construction in Saskatoon. Here she grew into a passionate safety professional while applying and understanding the dynamics of active construction projects from her technology background. In 2020, Tricia moved into the Health,

In accordance with Administrative Bylaws, **NOTICE IS HEREBY GIVEN REGARDING NOMINATIONS** to **TPS Board of Directors**.

"The Registrar, who shall act as returning officer, shall not less than one hundred and twenty (120) days prior to the Annual Meeting, inform the registrants in writing of the procedure for submission of nominations as outlined herein. Nominations shall be submitted in writing to the Nominations Committee Chairperson. Each nomination shall be supported by signatures of five (5) registered professionals who are not currently on the Board of Directors or registrants that have consented to let their names stand for office in the current election. The consent and signature of the nominee must also be provided in writing. Such nominations, properly endorsed, must be in the hands of the Nominations Committee Chair not less than ninety (90) days prior to the Annual Meeting."

#### MESSAGE FROM THE SASKATCHEWAN MINISTER OF JUSTICE

In early December 2025, Technology Professionals Saskatchewan received a letter from the Hon. Tim McLeod, K.C., Minister of Justice and Attorney General. It appears from the letter that the Minister is reaching out to all Saskatchewan professional regulatory bodies to share a message with their respective members. An excerpt from the Minister's letter is provided below.

On December 3, 2025, the Government of Saskatchewan introduced The Response to Illicit Drugs Act. This Act forms part of the Government's comprehensive strategy to protect families and communities from the dangers of illicit drug production and trafficking.

#### The new Act:

- creates a statutory cause of action against drug offenders, for both the Government as well as individuals who are harmed by those offenders; and
- · deems every appointment, grant or agreement made or entered into by the Government to be voidable if the other party is convicted of a drug offence.

The new Act applies to individuals convicted of production and trafficking offences for Schedule 1 substances under the Controlled Drugs and Substances Act. Schedule 1 covers some of the most problematic and addictive substances, such as fentanyl, methamphetamine, heroin and cocaine. The new Act does not apply to simple drug possession offences.

I am reaching out to Saskatchewan's professional regulatory bodies to seek your co-operation in protecting Saskatchewan citizens from the harms of illicit drug production and trafficking.

Professional regulatory bodies serve the important function of ensuring professions are governed in the public interest. As part of that function, you are responsible for overseeing your membership and taking necessary disciplinary steps when appropriate. Unfortunately, in certain instances this may include discipline of members who engage in illicit drug production or trafficking.


The Government believes professional regulatory bodies are in the best position to determine the appropriate professional consequences for members who engage in these illicit activities.

With the introduction of The Response to Illicit Drugs Act, I encourage all professional regulatory bodies to review member rules and disciplinary procedures and consider the appropriate response to rare instances where members engage in illicit drug production or trafficking. Your co-operation in this matter will play an important role in protecting Saskatchewan from the harms of illicit drugs.
